## PARENT AND FAMILY ENGAGEMENT

This policy was developed jointly with, and agreed upon and distributed to, parents and family members of District students. All parents of District students shall be notified of this policy in an understandable and uniform format, and, to the extent practicable, provided in a language the parents can understand. This policy shall be provided to the local community and updated periodically to meet the changing needs of parents and the District.

The Board of Education desires for meaningful parent and family involvement in the educational process for District students. To achieve that objective, the Board will:

- 1. Involve parents and family members in jointly developing the District's "local educational agency plan" under 20 U.S.C. §6312, and the development of support and improvement plans under 20 U.S.C. §6311(d)(1) and (2). The Board will do this by holding community work in conjunction with the District's Parent/Teacher Organization.
- 2. Provide the coordination, technical assistance, and other support necessary to assist and build the capacity of all of the District's schools in planning and implementing effective parent and family involvement activities to improve student academic achievement and school performance, which may include meaningful consultation with employers, business leaders, and philanthropic organizations, or individuals with expertise in effectively engaging parents and family members in education. The Board will do this through Business Advisory Council engagement and holding quarterly community engagement events.
- 3. Coordinate and integrate parent and family engagement strategies, to the extent feasible and appropriate, with other relevant Federal, State, and local laws and programs. The Board will do this by engagement with the Huron County Board of Developmental Disabilities and the Huron County Department of Job and Family Services.
- 4. Conduct, with the meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of this policy in improving the academic quality of all District schools, including identifying: (i) barriers to greater participation by parents in authorized activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background); (ii) the needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers; and (iii) strategies to support successful school and family interactions. The Board will do this by conducting parent surveys in conjunction with the District's Parent/Teacher Organization.

- 5. Use the findings of such evaluation in paragraph (4), above, to design evidence-based strategies for more effective parental involvement, and to revise, if necessary, the parent and family engagement policies described in this section. The Board will do this by reviewing the findings of the survey and implementing revisions as necessary.
- 6. Involve parents in the activities of the schools of the District, which may include establishing a parent advisory board comprised of a sufficient number and representative group of parents or family members served by the local educational agency to adequately represent the needs of the population served by such agency for the purposes of developing, revising, and reviewing the parent and family engagement policy. The Board will do this through outreach by the District's Parent/Teacher Organization.

## **Policy Involvement**

To facilitate the involvement of parents and families under this policy, the District shall:

- 1. Convene an annual meeting, at a convenient time, to which all parents of District students shall be invited and encouraged to attend, to inform parents of the District's obligations under 20 U.S.C. §6318, and to explain the requirements of that statute and the right of the parents to be involved. The District will do this by holding an annual open house prior to the start of each school year.
- 2. Offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, child care, or home visits, as such services relate to parental involvement. The District will do this by posting video presentations on the District's website and holding parent information meetings during the school day once school starts.
- 3. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this policy, including the planning, review, and improvement of this policy and the joint development of the schoolwide program plan under 20 U.S.C. §6314(b). The District will do this by placing a time for discussion of this issue on the monthly Parent/Teacher Organization meeting agenda and reviewing the programs during the public participation portion of the meetings.
- 4. Provide parents of participating children: (a) timely information about programs under this policy; (b) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards; and (c) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. The District will do this by holding periodic parent-teacher conferences, sending individualized letters to families, and sending nine-week student progress reports.

5. If the schoolwide program plan under 20 U.S.C. §6314(b) is not satisfactory to the parents of students, the school will submit any parent comments on the plan when the school makes the plan available to the Board. The District will do this by encouraging parents to submit comments to the Superintendent to be addressed at monthly Board meetings and/or encouraging parental attendance at monthly Board meetings.

# **School-Parent Compact**

The Board desires for parents, the entire school staff, and students to share the responsibility for improved student academic achievement. The means by which the District and parents will build and develop a partnership to help students achieve the State's high standards are as follows:

1. Describe the District's responsibility to provide high-quality curriculum and instruction in a supportive and effective learning environment that enables its students to meet the challenging State academic standards, and the ways in which each parent will be responsible for supporting their children's learning; volunteering in their child's classroom; and participating, as appropriate, in decisions relating to the education of their children and positive use of extracurricular time:

Within the next seven years, all New London Local School students will demonstrate that they have achieved a high level of understanding in all subject areas. Our schools will provide a safe, comfortable, positive environment that promotes individual and group learning styles and experiences.

The mission of the New London Schools is to work with and unite community resources to provide continuously improving academic, extracurricular, and work related programs designed so that all students can achieve a successful level of performance.

2. Address the importance of communication between teachers and parents on an ongoing basis through, at a minimum: (a) parent-teacher conferences in elementary schools, at least annually, during which the compact shall be discussed as the compact relates to the individual child's achievement; (b) frequent reports to parents on their children's progress; (c) reasonable access to staff, opportunities to volunteer and participate in their child's class, and observation of classroom activities; and (d) ensuring regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand. This will be accomplished by report cards mailed home; providing staff directory information; establishing parent-teacher conference dates on the school calendar, and posting electronic on-line grade books with parent access.

# **Building Capacity for Involvement**

To ensure effective involvement of parents and to support a partnership among the District, parents, and the community to improve student academic achievement, the District:

- 1. Shall provide assistance to parents of District students, as appropriate, in understanding such topics as the challenging State academic standards, State and local academic assessments, the requirements of 20 U.S.C. §6318, and how to monitor a child's progress and work with educators to improve the achievement of their children. The District will do this by providing open-door drop-in hours for parents and a "Questions Corner."
- 2. Shall provide materials and training to help parents work with their children to improve their children's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parental involvement. The District will do this by hosting annual academic nights and open house, as well as a dedicated space on the District website for materials and training opportunities.
- 3. Shall educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school. The District will do this by creating a module within the District's online staff P.D. platform for yearly review and completion.
- 4. Shall, to the extent feasible and appropriate, coordinate and integrate parent involvement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children. The District will do this by encouraging collaboration with state and local governmental agencies to hold community forums.
- 5. Shall ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand. The District will do this by providing District documents in various languages to meet the needs of the community.
- 6. Shall provide such other reasonable support for parental involvement activities under this policy as parents may request. The District will do this by meeting reasonable parental requests.
