### OT & PT SERVICE BID SPECIFICATIONS

The "consultant" providing the occupational therapy (OT) services and physical therapy (PT) services by registered occupational therapists and certified occupational therapy assistants, and registered physical therapists and physical therapy assistants will be responsible for the following:

- 1. Maintaining all necessary state licensure requirements by the OT/PT and Ohio Department of Education licensure boards, enrollment in Rapback if required; staff will abide by these requirements.
- 2. Maintaining and providing proof of professional liability insurance.
- 3. Maintaining and providing proof of BWC insurance.
- 4. Providing direct/indirect occupational therapy evaluation and treatment services to students for the 25-26 school year or extended school year as directed by the district.
- 5. Recording students' evaluation and treatment progress.
- 6. Ability to process billing for Medicaid services.
- 7. Providing information for the development of students' Individualized Education Programs and Evaluation Team Reports.
- 8. Providing services to meet district needs for all students through response to intervention model services as needed.
- 9. Availability to render services in-person during normal school hours.
- 10. Providing information as requested for EMIS and/or other state and federal reporting requirements.
- 11. Maintaining the requirements of 45 CFR 164.504(e)(1) for safeguarding and limiting access to information regarding beneficiaries.
